DID YOU KNOW

Most of you are aware by now that every Unit in the LA FRA Organization must have an EIN #. If you do not have an EIN #, you must apply to the IRS for your number. You may go on line or you may call their toll-free number. They are very helpful in telling you how to acquire your number. You must have an EIN# for your Unit and it cannot be with or through the Branch. If you do not have this, you are not a tax-exempt organization and the IRS can charge you taxes on any money that you have. This is also true with the National LA FRA. If all Units of the organization do not have their EIN then the IRS can pull the Charter of the LA FRA, since we are organized under a non-profit organization.

When you apply for your bank account in your Units name and Number, the bank requires you to give them a copy of your EIN for them to be able to open your account as a non-profit business and therefore, not charge a fee for the account. Having an EIN# does not mean you have a number to use when you make purchases, that is a whole different form. The EIN that we are talking about here is for organizational purposes only and to avoid having to pay taxes on all money that we may accrue for charitable purposes.

When you get your number, you must send a copy to the National Treasurer. The National Treasurer must have a copy of all Unit EIN's for the National files as proof to IRS in case a requirement is made by the IRS to see them.

Your EIN must be renewed on a yearly basis. Each year you will fill out a 990 form and as soon as you receive your renewal, you must send a copy to the National Treasurer. Each Unit must comply.

If you need assistance, you may ask your Regional President, and she will find the answers for you. I want to thank all of you for your compliance in this matter.
