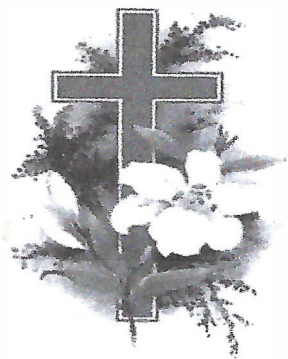

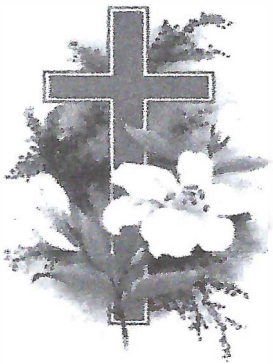

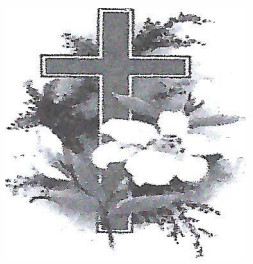

Installed as National President September 26, 2020. The first LA FRA National Board of Directors meeting for 2020-2021 was held immediately with a full slate of officers. The National Appointment Roster was completed to include a Communication and Publicity Committee. I announced the National Presidents goals and objectives to overcome the loss of membership due to non-payment of dues, expand the distribution of Auxiliary information to the members, increase communication with the members to keep them informed and just to stay in touch with the members.

In October, I attended the FRA's Installation of Officers and the FRA 1<sup>st</sup> National Board of Directors Meeting to represent the Auxiliary of the Fleet Reserve Association, brief the NBOD and announce the National Presidents Project "Special Operations Warrior Foundation". I attended Unit 40's Business Meeting and the Installation Ceremony of EC Regional Vice President Christopher Murray. During the month of November, I was honored to attend Unit's 40, social held in my honor.

Attended Branch 40 Chesapeake's, Veterans Memorial Service held in for the Military Personal that gave their life for their country, November 7<sup>th</sup>, to place a Memorial Wreath, in their memory. I participated in the Flag Retirement Ceremony conducted by the Venture Scout Group.

Limited travel and restrictions prevented public interaction; therefore, throughout the year, to improve communication, and to "keep in Touch", with the FRA and Auxiliary membership, National Presidents Greeting began in November. They were emailed to the Auxiliary's and FRA's Regional Presidents, Unit/Branch Presidents and Secretary with a request for dissemination to the membership. The greetings included Veterans Remembrance Day, Marine Corps Birthday, Navy Birthday, Coast Guard Birthday, Thanksgiving Day, Christmas, New Years, Valentine Day, St. Patrick's Day, Memorial Day, Easter, Mother's Day, Father's Day, and Independence Day. To promote the FRA and the Auxiliary the greetings were posted on multiple Face book pages.

COVID restrictions continued and prevented the National Presidents 1st meeting with the Regional Presidents, at a convention site, therefore I contacted each my phone to ensure the receipt of the Regional Presidents Manuals and procedures and to brief each on the National President's goals and objectives.

During the month of December, I spent the traditional holidays with family and friends, assisted Unit's 40 by collecting, purchasing, and delivering the toy donations to the Marine Toys for Tots Program. I donated more than 200 articles of clothing to a Church's Clothes Closet that assist you men in need and provide clothing to men seeking employment and better their lives.

I held telephone conferences with the NP's Administrative Team, NVP Pat Suckow, NES Vera Thomas, NFS Brenda Horton, Communication and Publicity Committee Chairman, Doris Fri, We devised methods to improve communication, increase the distribution of the monthly Triangle and Auxiliary information to keep the Auxiliary informed, to forward correspondence to regain lost members, to keep in touch with the membership during the restricted time of the COVID pandemic and in the future. The team ideas and recommendations were developed and put into effect to provide successful results throughout the administrative year. The Triangles distribution network grew from 752 to 2800 and continues to grow. A network/email list, was established to distribute Auxiliary information, dues notices, notices of greeting, etc. Simple Forms were developed by the NFS and inserted in all mailings to solicit email addresses and provide applications to subscribe to the Triangle. This was accomplished at a cost savings or at no additional cost to the Auxiliary and resulted in the expansion of the distribution of information and improved communication to the membership. I participated in Unit 40's Funeral Ritual for Joann Spires, a member of Unit 40 Member and Unit Chaplain. I attended the Funeral of Shipmate PRPEC Ray Santee.

I traveled to Jacksonville, FL to attend the SE Region's Midyear Meeting February 20<sup>th</sup>, and joined Regional President Gale Nathan's workshop to share ideas and the NP Goals. Traveling on to Pensacola Fl., I attended the FRA's Memorial Service for PNP Mark Kilgore at the Barrancas National Cemetery. I then traveled to the home of FRA Branch and Unit 22 to attend the Celebration of Life for Mark and the dedication of the Branch Home as "Mark A. Kilgore Branch 22".

During the month of March, I was pleased to attend Unit 99's Membership Drive as they served a "Drive By Spaghetti Dinner" to potential members. Unit 99 successfully recruited 3 new members.

I attended the NE/NENG FRA Regional Branch President's meeting via teleconferences via invitation to promote the Auxiliary of the FRA in the Region. I traveled to their Mid-Year Meeting and Institution of Unit 31 sponsored by Branch 31 with the assistance of Donna Jansky, Jr. PNP, Branch 31 Secretary. Throughout the year, I worked very closely with the new National Financial Secretary Brenda Horton, we had some challenging moments but as I know how difficult the first year can be.


I did not do much traveling as I would have liked to, but I am sure I will make up for it this coming year.

**Remarks of other work done:** Madame President Scarbro, this year has been primarily involved in the learning process of the NFS , especially the Membership portion of the Duties and Responsibilities and I appreciate all the patience and understanding received from the NBOD, Regional Officers Units and especially the members. There is a list of the supplies that are on hand and the value is included in the NFS inventory. In October training, by NVP (past NFS) Pat Suckow, of the NFS Duties and Responsibilities took place along with the delivery of the NFS supplies. I appreciated her patience while I learned the various aspects of the NFS with special reference to the membership section. The LA FRA History Book was one of the NFS projects that required an update involving the past 5 year. I appreciate the PNP's during that time, providing their history and their NP photo. The documents were reviewed, and current data was inputted. I contacted PNP to determine what they might be missing to make their Book current. The Book was available for sale in February and after advertising in the Triangle with the help of Vera Thomas, NES, seventeen books plus inserts have been purchased. Thanks to Doris Fri, PNP the complete History Book is now on thumb drives. A commitment was made to Units as to posting of dues, PCTS, and new/reinstated members with database month end closing of the membership the 25<sup>th</sup>. As of this date this commitment has been kept. I deposited due payment checks twice a month to expediate the processing -cancellation of the check. From the onset of the NFS year, members that were 60 days past due, received a 'Oops' reminder card. On a monthly average, 5-7 cards are returned with the member's payment. In January 2021 accessing the membership database, current email information of members by Unit allowed me to forward the information to the Vera Thomas, NES, for increase distribution of the *Triangle* '. Accompanying each dues statement or membership card, a request was inserted in the envelope asking for the member to review their recorded birthdate, phone number and requested if they had an email to provide it, or to make any necessary changes for corrections. The response has been positive with an average of 30 -35 existing members monthly correcting their information. Review of members profile noted 28 members without listed sponsors. I contacted them and the information has been recorded. The membership year ended on March 31, 2021, and reports distributed as to voting strength, loss/gain of membership, designated Group # for all units. There was an error in closing the year end that distorted stats but has since been corrected. In April I travelled to Peabody, MA to partake in the Institution Ceremony for Unit 31 – North Shore and in June, I attended the Pilgrimage and NBOD gathering. In August I attended the WC Regional Convention and throughout the year I participated in my Unit 137 meetings and activities. I presented 2- 50-year pins, 1 Memorial Day Service, 1 recruitment event and attended 2 PRPWC funerals. NFS Monthly reports, Quarterly and Annual reports were completed and by NFS team audited. I am thankful to Susan Hamarlund, Joyce Jackson and Jan Solberg for their time spent and efforts in ensuring accuracy of these reports. I am grateful for the words of wisdom from Nadine Fulton, NT and Diane Hoover, Budget Chairman. Thank you again, President Jackie and the National Board of Directors. It has been an immense pleasure to serve as NFS.

The LA FRA National President Project 2021-2022, K9s for Warriors was approved by the LA FRA National Board of Directors October 4, 2021, and is forwarded to the FRA National Board of Directors requesting ratification.

K9s for Warriors is an American tax-exempt 501c (3) nonprofit organization, which provides PTSD service dogs of the highest quality at no cost to those in the program to help restore their physical and emotional independence. This was established in 2011.

**MISSION:** is to provide service canines to the warriors suffering from Post-Traumatic Stress Disorder, Traumatic Brain Injury, and/or Military Sexual Trauma because of military service. When the service member comes back from a Military Conflict some have distinctive experiences that result in feeling different and acting differently. They understand that this attitude is Post Traumatic Stress. **BUT** what do you do? Where do you turn? Do you go to the Veterans Administration for help?

There is an alternative solution!!! Service dogs are such a magical and special creature. K9s For Warriors as they train and match veterans/dogs teams. Every warrior that walks through their doors becomes family. They are provided with a service canine, equipment, training, certification, seminars, legal instruction, vet care, housing, home cooked meals, unconditional love, and a lifetime of wrap-around services (including available lifelong healthcare and food for their dogs) The program is 100% free for the veteran. K9s are the answer for this problem. Warriors can return to their communities with a new **"leash"** on life as productive citizens who make a positive difference. After completing the three-week training program, the veteran will have gained the emotional means to repair their relationship with themselves, the families, and their friends. Hopefully, the Veterans Administration will **WAKE UP** to realize the very real need and solution that these dogs can provide for the Veterans.

Roughly 90% of their service dogs come from shelters or are owner-surrendered. Instead of a life of abandonment they are given a new purpose.

With each graduate pair, they save two lives:  
they rescue the dog, and the dog rescues the Warrior

This foundation was selected as the National President's Project because of the foundation's mission provides rescue dogs and train them to be life saving Service dogs for the veterans. The entire program also is provided at no cost to the veteran. They exist to stop the epidemic of suicides committee daily by the veterans.





## Year Served 2020-2021

### Report for National Parliamentarian:

The year started off with a legal review of the Membership of the LA FRA eligibility, the review of the current IRS regulations and letters of guidance regarding Veteran Service Organizations Auxiliary membership. I then worked with FRA National Parliamentarian to present to the National Board of Directors the recommended changes to C&BL 301 Membership eligibility to meet the IRS regulations. In question by the FRA, were the words "eligible at time of death" and "Stepchildren". Result NBR to change membership eligibility to remove "eligible" at time of death and the word stepson and step daughter with NBR worded to distinctly state recommendation to be presented to the Delegates at National Convention for Ratification as it was not an emergency change.

Reviewed and facilitated proposed changes for C&BL resolutions, and standing rules.

Reviewed changes to RP Manual and Updates to Standing Rules and C&BL's as passed in previous years and not updated in the online published addition.

Requested Region C&BL's from all regions to ensure the latest copy was available in the Parliamentarian book.

Reviewed the 2020 IRS regulations regarding collecting a W9 from Volunteers, scholarship recipients and National Board Members and sending 1099- MISC or 1099-NEC to any individual receiving more than \$600 from the organization for allowances/scholarships. Result we will need to adjust the record keeping. Or issue 1099's and the individual will be responsible to prove it was not taxable income.

1) The scholarship checks are written payable to the university so no need to issue a 1099 to the student.

2) RP's need to submit receipts to get reimbursed for expenses up to \$120/region. so no 1099 for these. The travel to National Convention up to \$600 paid at .21/mile and Hotel allowance \$75/day is far less than the IRS allows for mileage and per diem and the cost of the hotel and food found at perdiem.gov, therefore, no one is receiving taxable income for travel & hotel resulting in a 1099. The RP must submit a flight receipt, report stating number of days at hotel and their cost per day. At the end of the term they are provided an allowance based on work completed and will be directly related to the reports sent to the National President for Unit's visited/attendance at Regional Conventions to include any out of pocket costs for hotel, meals, air fares/miles traveled not reimbursed by the Region or paid by the hosting Branch or committee with copies of receipts submitted with the reports. **Cost should equal or exceed allowance so the 1099 would not be required. No reports provided from RP quarterly = no funds issued at the end of the term. National Convention air fare must be substantiated with receipts and include dates of arrival and travel home.**

3) The part that now comes into question is the yearly/monthly allowances for NT, NFS, NES, NP, and NVP. These costs when provided were intended to offset the expenses of going to the post office, bank, visiting Units, attending Pilgrimage, Regional Conventions, Mid- Year meetings and National Convention (costs not covered by travel & hotel allowance). **We will now need a report and receipts from the officers similar to the report RP's are required to complete recording date, activity, miles driven/flight info, hotel costs, and food costs. Number of days away from home substantiated by receipts. National Officers cannot do their position without the use of telephone and internet. The Organization will allow a reimbursement for these items. When you itemize these costs, the costs should equal or exceed the amount the Auxiliary has authorized as an allowance and therefore no**



**taxable income to the Officer. However if an officer fails to provide copies of receipts a 1099 will be issued.**

4) Per the C&BL's the newly elected RP's are provided \$400 at post board meeting: This offsets their travel home and initial travel expenses to visit units in their region, **We will need to require statements as to how the incoming RP traveled to convention: drive or fly to National Convention Installation, ticket itinerary with costs or # of miles driven to record the offset for these expenses. A W9 must be collected before any funds are issued at Post Board.**

**Since the premise of a Veteran Service Organization is NO ONE receives a PROFIT from their membership, or service provided to the organization. NO ONE should have taxable income for their allowance reimbursements.** This was discussed at the National Board meeting held 29 June and with the budget and finance committee.

**Reviewed C&BL's regarding the Fidelity Bond due to the inability to get an umbrella policy to cover all Units due to the changes in the Insurance world.** Recommend NBR as it is an emergency situation with coverage ending July 10<sup>th</sup>. Discussed at NBOD meeting June 29<sup>th</sup> C&BL and standing rule changes submitted for delegates to vote.

Reviewed request for NES Computer and accessories. This is a necessary expense covered by equipment budget line item so that the TRIANGLE can be published, and reports sent from NFS/NT can be opened and reviewed for publication by the NES.

Robert's Rules new addition, reference sheets as well as legal reviews by FRA and IRS non profit and Veteran Services manuals were utilized. I encourage everyone I talk to become familiar with the Unit Procedure Manual, C&BL's and Standing Rules.

I attended 4 funerals and assisted 2 widows with information on how to apply for VA benefits DIC and SBP. I utilized the FRA Action Center to contact Congressmen and Senators regarding the SBP offset, Concurrent receipt of Veterans Benefits (for those with less than 50% disability) and repeal of TRICARE Standard enrollment fees.

I installed the Officer's at Unit 99 and attended installations at Branch 293, Branch 99, Branch 166, and Unit & Branch 40. I attended East Coast Mid-Year via Zoom and attended the East Coast Regional Convention via Zoom. I attended the Pilgrimage to Arlington and the Tomb of the Unknown and the Ceremony at the Mast of the Maine. Attended bi-weekly meetings for the 2021 National Convention as the LA FRA Co-chair. Attended Monthly Board of Director and General Meetings at Unit 40 and assisted with activities and welfare projects. Attended Memorial Day event in person and Veteran's Day and Pearl Harbor Day events via zoom/Facebook live.

Remarks on work done as Communications and Publicity Chairman: New committee and new challenge.

Everything that was accomplished this year was a team effort and much brain storming and lots of trial and errors. NP Jackie challenged us to reach out to as many members as possible to ask them for email addresses and to offer them as much information as they would like to have by way of Regional Newsletters, the Triangle, National Convention News, Regional Events etc.. We asked them to send us their email address so we could add them to our Communications Group to receive all information, greeting cards, etc.. from the Auxiliary directly sent to them. Because we have so many members that are unable to attend meetings, for various reasons, they are not always in the "Information Loop". Many members do not have the ability to go on the Website to read or download information.

With the help of RPNC Lisa Barton and RVPNC Chris Drew, North Central Region started a project called "Communication Train". RVPNC Chris found a picture of a train that was suitable for the heading of our "Invitation Letter". The letter was sent out to ALL NCR members, ALL MAL members who reside in the NCR and members from other Units who reside in the NCR. Approximately 300 letters were sent out.
