Resolution to amend C&BL Section 301(a)

Proposed by Unit 40 Chesapeake

To clearly define eligibility for membership in the LA FRA and to meet current IRS regulations

**Whereas**, Section 301(a). currently states....Membership in the LA FRA shall be limited to spouses, parents, grandparents, sisters, brothers, children, stepchildren, and grandchildren not less than sixteen years of age of members of the FRA and widows, widowers, parents, grandparents, sisters, brothers, children, stepchildren, and grandchildren not less than sixteen years of age of persons who were members at the time of death or eligible to be members of the FRA at the time of death.

**Whereas**, as presently written section 301(a) does not meet the current IRS regulations for a 501 c 19 exemption criteria as it pertains to auxiliaries and


**Whereas**, the FRA requested a legal ruling regarding "Is the LA FRA bylaw section in conflict with the FRA bylaws" and "Does the Auxiliary bylaw conflict with the IRS 501 (c) 19 exemptions" this ruling was completed and the NP FRA requests LA FRA NP review the legal interpretation and remove the words "**eligible at the time of death**" and

**Whereas**, the legal precedence states the wording in Sec. 301(a) "...or eligible to be members of the FRA at the time of their death" may not comply with IRS section 501(c) (19). The IRS restricts membership in the auxiliary to members of the FRA, spouses of those members, or those related within two degrees of consanguinity. Eligibility at the time of their death is not the same as being a member of FRA at the time of their death. In fact, the definition of the word "eligibility" is "the state of having the right to do or obtain something through satisfaction of the appropriate conditions." Have the right to do something and currently being a part of something are different" and


**Whereas**, membership for an Auxiliary in IRS publications state members are either veterans (LA FRA has several female veterans who joined the Auxiliary when the FRA only allowed men to be members), or spouses/widows of veterans, or are related to a veteran within two degrees of consanguinity (defined by the IRS as within two degrees of Bloodline kinship) (i.e., grandparent, brother, sister, grandchild, represent the most distant allowable relationships).

**Resolved**, that C&BL Section 301(a) be amended to read as "Membership in the LA FRA shall be limited to spouses, widows, widowers, parents, grandparents, sisters, brothers, children, and grandchildren not less than sixteen years of age; of members of the FRA, or of deceased FRA members.

This is to certify that this resolution was proposed at a regular meeting of Unit Number 40 held on 21<sup>st</sup> day of April 2021 and read, debated and adopted by an unanimous vote at a regular meeting of Unit 40 held on the 19<sup>th</sup> day of May 2021 there being a quorum present.

If a Unit or member wishes to purchase a full complete LA FRA History Book submit a Price List/Order Form. Cost is \$40 and supply is limited. Inserts mailed \$20, emailed FREE. **The Office for the National Treasurer** will become vacant this administrative year. Units may submit Resolutions per C&BL Article 6 Section 608 to nominate candidates for the position to be considered at the National Convention. Resolutions are due 120 days before the Convention and may be submitted to the National Executive Secretary. The duties are as outlined in the Constitution and Bylaws.

#### Duties of the National Treasurer C&BL Article 8 Section 810

Section 810(a). The National Treasurer is responsible for the accurate and proper maintenance of the financial records of the LA FRA. An accurate and true record of all receipts and disbursements shall be recorded and no change shall be made without the approval of the NBOD. Supply the NBOD, and the Audit Committee and Budget and Finance Committee with information as may be requested and allow any authorized committee or authorized member to examine or audit the books and accounts at any time.

Section 810(b). Upon receipt of properly drawn voucher, the National Treasurer will issue a check. The signatures of the National Treasurer and the National President will be on all or may be affixed by a signature stamp. If the bill is irregular or in some manner out of order, the Treasurer has the authority to refer the matter to the NBOD via the National President for decision.

Section 810(c). The National Treasurer submits quarterly reports, which have been audited, to the NBOD and to all Units showing receipts and disbursements, and issues any other reports as directed by the NBOD. The National Treasurer prepares and makes an Annual Report to the NBOD and to the National Convention, showing gross receipts, expenditures, and balances on hand at the end of the fiscal year, together with recommendations. Recommendations requiring action of the National Convention shall be in official format with copies for the delegates.

Section 810(d). The National Treasurer prepares an inventory of all tangible properties of the LA FRA with the following information: name of equipment, location of equipment and whose inventory; price when purchased; present estimated value; and all other information pertinent to the subject. The inventory is to be submitted to the NBOD Pre-Convention meeting.

Section 810(e). No, LA FRA properties of any value shall be surveyed, sold, or destroyed, without prior approval of the NBOD.
