



Subject: LA FRA C&BL Article 9 - Finance Policy, Section 904 General Funds, Subsection 904(c) Fidelity Bond.

Whereas, C&BL Article 9 - Finance Policy, Section 904 General Funds, Subsection 904(c) Fidelity Bond states National Officers, and Unit Officers that have custody of Auxiliary funds shall be bonded under a Position Fidelity Bond. The National Treasurer, and the National Financial Secretary, shall be bonded for an appropriate amount as recommended by the National Budget and Finance Committee to the NBOD. Premiums on the bond shall be paid from the funds of the Treasury, and

Whereas, Article 9, Section 904(c) list National Officers, and Unit Officers that have custody of Auxiliary funds shall be bonded under a Position Fidelity Bond, and

Whereas, The National Financial Secretary's recent solicitations to four (4) insurance agencies which have submitted applications on behalf of the LA FRA, with specific bid detail, to various insurance companies, and

Whereas, The response to all requests was that the insurance companies declined coverage, as they no longer write policies that cover this number of volunteers and the LA FRA geographical area, and

Whereas, The National Financial Secretary has not been able to locate an insurance company that will issue a policy covering the LA FRA National and Unit Officers, and

Whereas, National Officers that are directly responsible for handling LA FRA funds are the National President, National Vice President, National Treasurer, and National Financial Secretary, and

Whereas, the LA FRA National budget cannot support on an annual basis the number of policies that would be required to bond the Unit officers, now, therefore, be it

**Resolved,** The LA FRA National Board of Directors presents to the delegates for ratification that C&BL Article 9, Section 904 General Funds, Subsection 904(c) Fidelity Bond shall state: National Officers that have custody of Auxiliary funds shall be bonded under a Position Fidelity Bond. The National President, National Vice President, National Treasurer, and National Financial Secretary shall be bonded for an appropriate amount as recommended by the National Budget and Finance Committee to the NBOD. Premiums on the bond shall be paid from the funds of the Treasury.

Whereas, The LA FRA National budget cannot support an expenditure for the Fidelity Bond premium, for all units, on an continual annual basis, now, therefore, be it

*Resolved,* The LA FRA National Board of Directors presents to the delegates for ratification that C&BL Article 14 Unit Organization, Section 1409 Fidelity Bond *be deleted* from the LA FRA C&BL and, be it further

**Resolved**, That with the deletion of Section 1409 the following be renumbered to continue consecutive numbering with 1410 renumbered to 1409 and 1411 renumbered to 1410, etc.





