The following are the LA FRA Standing Rule (SR) resolutions that have been ratified by the FRA. Remember to change your copy of the Standing Rules to the ratified versions listed below.

SR 9: Membership dues in the LA FRA shall be twenty-five dollars per annum, payable in advance, not to exceed five years at any time. Any advance dues payment shall be non-refundable. Application for new, reinstated or renewal of memberships shall be accompanied by payment of twenty-five dollars effective with renewals due on or after 1 January 2022 and those who have prepaid their dues will not see the increase until their next renewal date.

SR-10(n): Minutes of the convention shall be recorded by the National Executive Secretary in a summarized format and contain the date, time, and place of the convention, the fact that proper notice was given for the convention, states whether or not a quorum is present and Units represented by means of the credentials report, includes that name of National Board Members present, a list of members recognized during the memorial service, copies of printed officer, chairmen and committee reports, and tally sheets as voted. Includes all motions specifying who proposed the motion, whom seconded the notion and the results of the voting action. Ensures minutes are properly assembled, labeled, numbered and signed by the National Executive Secretary and the Jr. Past President before being published by electronic means with hard copies retained for the perpetual file.

SR-10(o): The minutes are distributed by electronic means within one hundred and twenty days following Convention. Minutes will be posted on the LA FRA website. An email will be sent to each Unit, National Officers (of the immediate past and current administration), and the FRA Administrative Headquarters advising minutes are posted. One hard copy is to be retained in the perpetual archive files. Members may purchase copies of the convention minutes, if ordered and paid for in advance, within forty-five days from the close of convention.

SR-22(c): Any member may subscribe to receive a hard copy of The TRIANGLE for ten dollars per year. Money order or check payable to LA FRA for the subscription shall be mailed to the National Financial Secretary and any member who wishes to receive a free "no cost" electronic version via email may submit their email address to both the National Financial Secretary and the National Executive Secretary.

Add -SR-22(f) A member may submit an Email or electronic transmissible address to be included on the Triangle's electronic distribution list.

SR-24(b): Supplies for Purchasing-A list of supplies for Units to purchase will be furnished by the National Financial Secretary with current prices, and sent to the National Web Master, who will publish on the national web site, in the list of Forms and also sent to the National Executive Secretary who will publish at least once a year in "The Triangle".

SR31(a)1: Uniform cap worn by members of the Auxiliary shall be as follows: (1) For female members, A silk lined overseas type of Cap of Navy blue and gold, with crown to be as of gold twill, or other suitable material, the apron to be of Navy blue woolen cloth, or other suitable material. The Unit number shall be in front, and, if desired, the Unit geographic location and the highest office held, with years served, shall be on the left side, embroidered in gold. In addition, the name, Auxiliary of the Fleet Reserve Association may be embroidered in gold, on the right side. Grandfathering all prior hats bearing the name Ladies Auxiliary of the Fleet Reserve Association. All prior hats bearing the name Ladies Auxiliary of the Fleet Reserve Association are grandfathered, thus requiring no one is change their current hat and any member who feels so strongly that any new hat they may buy also state Ladies Auxiliary of the Fleet Reserve Association may do so.

SR-31(a)5: For Honorary Members, the same as for general membership except that words "Honorary Member" shall be embroidered in gold on the left side above the name Auxiliary of the Fleet Reserve Association. A former member of the Auxiliary, now an Honorary Member, may wear the cap that was earned in the highest office held gray for Past National Officers and red for Past National Presidents. All prior caps bearing the name Ladies Auxiliary of the Fleet Reserve Association are grandfathered, thus requiring no one to change their current cap.

SR-33(b) 1: The Awards of Merit are based on annual reports for the Unit Administrative Year submitted by Unit Chairmen of the following committees: 1. Activities 2. Americanism-Patriotism 3. Hospital 4. Publicity 5. Unit Report 6. Welfare and Rehabilitation 7. Youth Activities.

SR-33(b)(3): The Regional Chairman and the Committee judges these reports according to the SR and report form instructions and report to the Regional Convention. The first place Regional winners in each of the four groupings, for the Unit Report, shall be submitted by the Regional President of their respective Region, to the National Executive Secretary at the Pre-Board meeting for distribution for judging by the National Committee. The Regional President retains one copy of each report.

SR-33(b)(5): The National Unit Report Committee concerned reviews the award winning Regional reports and recommends to the assembly the appropriate Unit awards. This committee reviews the Annual Report Form and the Committee Chairman recommends suggested changes to the delegates at the National Convention.

SR-33(c): In the absence of the National Chairman, the National President appoints a Chairman to fill the position at the National Convention. All judging of the Unit Reports for awards shall be done at convention.

Withdrawn: C&BL Article 8, Section 803(d)(38); SR-14 and 23.
